

In 1989 Dr. Richard Kosaki put into motion his idea of establishing a Foundation to financially assist McKinley High School with not only special programs at the school but the awarding of scholarships to deserving graduates of McKinley. This was the beginning of the McKinley High School Foundation. Today the Foundation flourishes and in 2007 63 students received scholarships to help them further their education. It has been eighteen years since Dr. Kosaki's dream of helping McKinley since that time the Foundation has awarded over 360 students with scholarships - amounting to over \$665,000. 
